

INSTRUCTIONS TO THE TRAINEES

1. Trainees are directed to report for joining in WBFS, Dowhill & ~~SFTI~~, Hijli by schedule date. **No late joining will be allowed.**
2. Trainees are directed to maintain strict discipline during the entire period of training.
3. Trainees are directed to bring the following items for their use during the training:-
 - i) A small trunk/suitcase
 - ii) Bedding and clothing
 - iii) A mosquito net
 - iv) 2 full sets of uniforms for their use.
 - v) Raincoat and umbrella
 - vi) Other personal essentials for daily needs.
4. Trainees are directed to maintain strict discipline and etiquette in the Training Campus & Dining Hall and other common areas during the training.
5. Trainees are also directed to follow the instructions strictly given by the Director and other instructors which includes morning physical exercise and evening games. These activities are part of the training and no exemption in normal circumstances will be allowed from these activities.
6. Normally no leave will be granted during the training but in exceptional circumstances the trainees may be allowed medical/sick leave by the Director and granting of leave during the training will be the sole discretion of Director, WBFS, Dowhill & ~~SFTI~~, Hijli.
7. Trainees will be personally liable for damage of any property which has been either given to them during the training or the common properties which will be utilized during the course of training.
8. The training is mandatory in nature and generally no exemption from attending any specific class or exercise will be allowed. However, in exceptional circumstances, the Director, WBFS, ~~Dowhill~~ SFTI, Hijli may take final decision in this regard.
9. Trainees are advised to bring sufficient money with them for their use during the training. After returning back to their respective units, the trainees will submit the normal T.A. Bill claiming the TA & DA as per rule for the training period.

The controlling officers are requested to release the above mentioned incumbents well in advance on the scheduled date and time, so that they can join the said training course on due date. The details instructions are enclosed with this order.

The Units, where the incumbents are now posted, will continue to disburse the Salaries / TE etc. of the respective Deputy Ranger/Foresters during the period of training. No DDO shall send the Service Book / Personal File of the released DR/Fr. / FG to the Director, SFTI, Hijli for the training period.


On completion of the said training, the incumbents shall join their respective Divisions from where they are deputized. No separate posting order will be issued in this regard on completion of the training.

If there is any proceeding / case continuing or punishment order has been issued against selected candidate/s, then such incumbent/s should not be released for the training. Details of such candidate/s should be reported to this office forthwith and substitute will be arranged.

This training is mandatory for all the selected ~~DR/Frs.~~ and FG. Please make the incumbent(s) aware that they will not be considered for further promotion, if they fail to attend as well as complete the training course successfully. If any exemption is extremely required then PCCF & HoFF will be the only competent authority to do so.

If any untrained ~~DR/Fr.~~ or FG under your control whose name does not appear in the list may also be selected for training (according to seniority). In that case, the controlling officers may be requested to send the names and details to this office as early as possible.

All trainees must have COVID-19 double vaccination Certificate.


