INSTRUCTIONS TO THE TRAINEES

1. Trainees are directed to report for joining in WBFS, Dowhill & SFTI, Hijli by schedule date. **No late joining will be allowed.**
2. Trainees are directed to maintain strict discipline during the entire period of training.
3. Trainees are directed to bring the following items for their use during the training:-
 - i) A small trunk/suitcase
 - ii) Bedding and clothing
 - iii) A mosquito net
 - iv) 2 full sets of uniforms for their use.
 - v) Raincoat and umbrella
 - vi) Other personal essentials for daily needs.
4. Trainees are directed to maintain strict discipline and etiquette in the Training Campus & Dining Hall and other common areas during the training.
5. Trainees are also directed to follow the instructions strictly given by the Director and other instructors which may include morning physical exercise and evening games. These activities are part of the training and no exemption in normal circumstances will be allowed from these activities.
6. Normally no leave will be granted during the training but in exceptional circumstances the trainees may be allowed medical/sick leave by the Director and granting of leave during the training will be the sole discretion of Director, WBFS Dowhill & SFTI, Hijli.
7. Trainees will be personally liable for damage of any property which has been either given to them during the training or the common properties which will be utilized during the course of training.
8. The training is mandatory in nature and generally no exemption from attending any specific class or exercise will be allowed. However, in exceptional circumstances, the Director, WBFS, Dowhill / SFTI, Hijli may take final decision in this regard.
9. Trainees are advised to bring sufficient money with them for their use during the training. After returning back to their respective units, the trainees will submit the normal T.A. Bill claiming the TA & DA as per rule for the training period.

The Units, where the incumbents are now posted, will continue to disburse the Salaries / TE etc. of the respective Deputy Ranger/Foresters during the period of training. (ii) **Releasing the Trainees** : It was affirmed that in case the trainees (DR/Fr or FG / FR) are not released by their controlling officers, expressed permission of the PCCF (HoFF) should be obtained by them.

Action: PCCF/RMD to move PCCF HoFF for issuing circular on this.

(iii) **Training of Compassionate ground appointee:** All back log of training of compassionate ground appointees should be cleared chronologically i.e. according to their seniority. If any of such recruit refuses / fail to attend the training, confirmation of such staff (s) will be withheld till his / her training is completed.

Action: CCF/PMC(non Gazetted cell)


(iv) **Board of Examiners** : List of Examiners will be changed from 109th Batch of DR/Fr. (up to 108th batch of DR/Fr. proposed list already approved vide agenda 4) where a panel of 2-3 examiners for each subject may be suggested, from whom set of questions along with their model answers with corresponding marks to be sought. Thus subject wise question banks would be prepared. The question paper for each subject would be finalized by drawing lots from those question banks. The panel of examiners shall be valid for 2 years.

Action: PCCF/RMD and CF/DC.

(v) **Cost of training:** The total cost of training as approved by SFTAC will be Rs. 75,000/- per trainee for departmental candidates and Rs. 1,00,000/- for outsiders. One month training cost will be as usual Rs. 12,500/- per trainee for departmental candidates and Rs. 18,500/- per trainee for outsider.

Action: Director/WBFS and Director/SFTI .


