The details of works that to be undertaken is given below:-

Monthly Hiring of LMV car for use as office vehicle for Conservator of Forests, Development Circle, West Bengal.

Terms & Conditions

- Car must be recent model having contract permit and in a tip top running conditions and having 5(five) km form the reporting place.
- 2. Car will normally use to travel within Kolkata and occasional official tour in Distance.
- 3. Driver of the vehicle have to wear uniform same as drivers of office of PCCF (HoFF)/WB.
- 4. A 'First Aid Box' have to be kept in the vehicle.
- 5. The Car be hired for 10(ten) hours a day to be counted the time of reporting to duty, up to release form duty.
- 6. Working hours beyond 10(ten) hours an overtime as per Govt. Rule.
- 7. Owner should provide Driver having valid license at his own cost & all repairs and running maintenance cost should be done by the owner of the vehicle at his own cost.
- 8. Fuels/Lubricants will be issued at the following rates:
 - i) For petrol engine car @8 K/Lter. Petrol of journey.
 - ii) For Disel engine car @ 12 Km/Ltr if diesel of journey.
 - iii) For engine oil (Mobil Oil) @ 5 Km/Ltr after every 2500Km of journey
- 9. All other charges as payments of taxes etc. including repair and maintenance of car to be done and borne by the owner of the car.
- 10. In case of breakdown of car the owner shall provide a substitute car.
- 11. Log Book to be updated daily including meter reading.
- 12. Car should be available on 24X7 hours basis for any emergency call of duty.
- 13. The distance travel to garage to reporting place will be recorded in the log book for taking account for consumption of fuel.
- 14. The car must have contract carriage permit as per Govt. Rules.
- 15. The owner will also to produce authentic documents related to the model and year of purchase.
- 16. The agreement shall remain valid at the present for one year and the same be extended further the agreement may be terminated after giving 15 days notice from either side.
- 17. The bill for hiring of the car should be submitted in duplicate for each calendar month within 1st week of the next month.
